Introduction

The TEC reviewed the Course Classification Guide in 2022. We have updated it to reflect changes required to implement the Unified Funding System (UFS), incorporate legislation changes, maintain currency, and include more specific guidance. We have renamed it the Delivery Classification Guide (DCG).

Information on the Numeric Code that gets used with the Alphabetic Code to determine funding is included as Appendix 1. A summary of major changes is in Appendix 2 at the end of the DCG. The most significant of these changes are:

- the introduction of new classifications for #40 Te Reo Māori and #41 Tikanga Māori
- the removal of #21: Trades 1 (all trade courses for trainees under the Industry Training and Apprenticeships Act 1992 and Agricultural, Horticultural, Forestry, and Primary Industry Cadets)
- the removal of #22.1: Vocational Training for Industry (all courses where delivery is comparable to Industry Training).

Using the DCG

Tertiary Education Organisations (TEOs) are required to classify their delivery using the current delivery classification prescription set out in this DCG.

All Degree/Diploma/Certificate or other awards/qualifications/micro-credentials described in the DCG must be appropriately approved, either by Universities New Zealand's Committee on University Academic Programmes (CUAP) or the New Zealand Qualifications Authority (NZQA) – along with the relevant delegated quality assurance body where applicable (i.e., the appropriate council or registration board).

As the TEC funds at a course level, we need information about the classification of each component part or course that forms part of a programme or micro-credential before we can approve a micro-credential or programme leading to a qualification as eligible to receive funding. Once a programme or micro-credential has been approved by an external quality assurance body, the TEO must disaggregate it into component parts or courses for classification.

Note that the disaggregation requirement does not apply to programmes reported to the TEC via the Industry Training Register (ITR). The Work-based, Work-based Pathway to Work and Assessment and Verification mode provision in these programmes is funded similarly to a programme classification, and the TEC assigns a single delivery classification and funding rate to each programme. Delivery of Provider-based aspects of these programmes is subject to the normal delivery classification requirements.

Where applicable, we have included detail on the UFS funding rate that TEC will assign.

Programmes and qualifications at Level 2 on the New Zealand Qualifications and Credentials Framework

In the Single Data Return (SDR), component parts and/or courses/within programmes at level 2 on the New Zealand Qualifications and Credentials Framework (NZQCF) can have a 'maximum' funding rate of F2 (delivery component funding rate category). For example, engineering trades at level 2 must be assigned course classification 22, not 11. In the ITR, this applies to each programme.

The Programme Basis Rule

There are some instances where we have approved a programme classification to allow a single classification code to be assigned to the entire programme of study.

A programme classification has been approved for specific programmes of study and applies to classification codes #07, #11.2, #15, #17, #19.1, #19.2, #20 and #23–37, to acknowledge the higher costs of delivery for

these programmes.

How to apply the classifications outlined in this guide

A summary of how to apply the classifications in the DCG is provided below. You should also refer to notes and guidance within each classification.

- When entering component parts or courses under the UFS, please enter the specified code and funding category. At least 90 percent of the content or subject matter must fit into the classification you have assigned to a course, unless the Programme Basis Rule applies.
- Refer to the Programme Basis Rule above, and the information for each classification, regarding provision that qualifies for the programme classification.
- Classification may also depend on the level, as component parts or courses in some disciplines are funded at different rates or under different codes, depending on the year of study. For example, Years 2 and 3 of an undergraduate Medical degree are classified as #15 while Years 4 through 6 are classified as #37, and postgraduate Medicine is classified as #15.
- To ensure that each component part or course is classified correctly, TEOs must assign a name that correctly describes the majority of content. This helps the TEC review the correct use of codes in our approval process.
- Where TEC believes an incorrect classification may have been used for a course or programme, we will contact you for clarification and amendment if needed.

Notes:

1. Floriculture is the cultivation and farming of flowers as a primary industry and is classified as #01. Floristry and Interflora courses are classified as #03.
2. Pre-vocational courses leading to Trade Certificates in agriculture, horticulture, forestry or primary industry, should be classified as #22. The exceptions to this note are vocational primary industry operational skills which are classified as #01.
3. Courses in hobby/relaxation/leisure gardening and secondary employment agriculture are classified as #5.2.

4. Farm Management, Resource Management and Rural Development are classified as #04. The exceptions to this are vocational courses with a focus on primary industry operational skills.
5. Animal Science, Plant Science and Soil Science are classified as #18.
6. For specialist unit standards there is provision for funding some content at the C1 level. This involves:
 - situations where learners undertake a 50 percent (or higher) component of practical study within a sawmill or cable-logging environment.
 - those components that require very high levels of supervision and/or safety equipment because of their intrinsic safety risks.
7. Specialised Agriculture and Horticulture at Level 5 and above that are targeted at primary industry management are classified as #01.

TEOs must report these Equivalent Full-Time Student (EFTS) units as cost recovery EFTS units.

This will be reviewed in the future for its suitability.

Postgraduate courses do not attract clinical training funding adjustments, so classify as #13.

Programmes or courses in this classification must involve a high degree of specialisation, be high cost, require high tutor/learner ratios, and be of national importance.
2. Classify Fitness and First Aid courses as #03.
3. To meet the criteria for classification as #13, a qualification in Physical Education (Sport and Recreation, Exercise and Leisure Activities) must:
 - be an integrated, full-time programme of study in research-based instruction at the undergraduate degree level
 - prepare learners to teach physical education and have a curriculum emphasis in human sciences, eg, exercise physiology, functional anatomy, biomechanics, with a major practical component requiring clinical fitness testing facilities
 - be taught by professionally qualified staff supported by qualified technicians.
4. Classify Pharmacy Technicians as #17. Classify Pharmacy Assistants as #03.
5. When Funeral Directing does not include embalming, but is offered as a separate qualification, classify as #03.
6. Classify courses not specific to the discipline but of general interest, eg, art, history or music, in the appropriate classification.
7. Classify New Zealand Sign Language qualifications, other than those for teachers and interpreters, as #03.
8. This category relates to a degree in Physiology. Classify Physiology courses contributing to other degrees as #18.

Years 4, 5 and 6 of Undergraduate Degree programmes have a clinical training classification #37 and must be separated from Years 2 and 3.

Postgraduate Degrees: Funding Category G3 – 4

Intermediate courses are disaggregated and classified in the appropriate classification.

Postgraduate courses do not attract clinical training funding.

Appendix 1: Numeric Code

The numeric code is paired with the alphabetic code to determine funding. It is determined by the level of study of the qualification that the course is part of. The numeric code categories are explained in the table below.

Numeric code (category) (classification by level and content of study)

1	Courses designed for non-degree qualifications with no research requirement, including certificates and diplomas
2	Courses designed for undergraduate degree qualifications, including bachelor's degrees, graduate certificates and diplomas
3	Courses designed for taught postgraduate qualifications, including postgraduate certificates and diplomas, bachelor's degrees with honours, and taught master's papers
4	Research-based** postgraduate qualifications, including master's theses/dissertations of 1.0 EFTS or more for master's and doctoral study

Example: An undergraduate Medicine course is numeric code 2. A postgraduate Medicine course is numeric code 3 (if a taught course) or 4 (if research based).

Numeric code 3 - Postgraduate qualifications

The essential principle of postgraduate education is that the learning involved is at Level 8 or higher on the NZQCF.

A certificate or diploma can be classified as a postgraduate qualification if:

- it is built on the undergraduate degree of the same discipline and at Level 8 or higher on the NZQCF, or
- it is equivalent to the first year (Diploma) or half year (Certificate) of a master's degree.

It is not appropriate to allocate numeric code 3 for an honours degree awarded as a result of the learner's superior achievement in an undergraduate course. A qualification cannot be classified as a postgraduate programme if:

- it is the fourth year of a four-year undergraduate degree, or
- it is a graduate certificate or diploma that equates to the final year of an undergraduate degree, and is open to graduate learners from a variety of disciplines.

An honours course can be categorised as postgraduate if:

- the honours programme requires admission from a completed bachelor's degree
- a learner is specifically admitted into a final-year honours stream, or
- a course is specific to an honours stream.

Numeric code 4 – research-based postgraduate qualifications

The Delivery on the NZQCF at Levels 7 (degree) and above (DQ7+) definition for 'research-based', and therefore eligible for DQ7+ numeric code 4 funding rates, is that the research component comprises at least 1.0 EFTS. This is different from the [Performance-Based Research Fund \(PBRF\)](#) eligibility criteria for research degree completions, which include recognising qualifications with research components totalling 0.75 EFTS or more.

You may allocate numeric code 4 for research-based postgraduate qualifications, including a master's thesis/dissertation, of 1.0 EFTS or more for master's and doctoral study.

You may allocate numeric code 4 for a research-based postgraduate qualification if the qualification meets all of the below criteria:

- It has an EFTS value of at least 1 EFTS. This total value may be spread over more than one year.
- It includes one or more courses at Level 8 or higher on the NZQCF that total a minimum of 1 EFTS.
- It requires a learner, who is supervised, to produce a substantial research output that amounts to 100% of the learning and assessment for that course.

A course that is preparatory to a thesis, such as research methods, is not a postgraduate course.
