



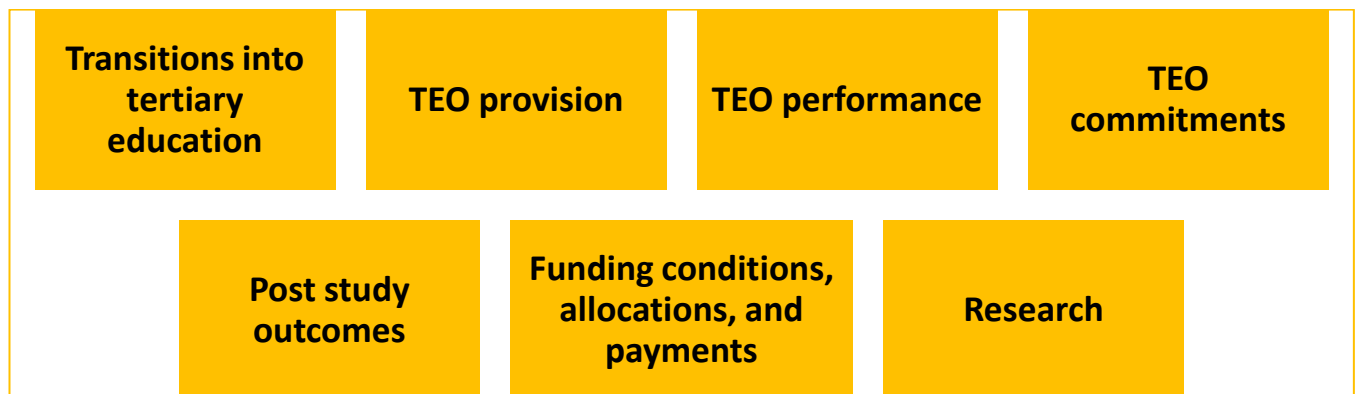
Infosheet: Using Ngā Kete to inform your Investment Plan information

We publish Ngā Kete Information Products (info apps) on the [Ngā Kete website](#). These info apps are intended to make it easier for you to view and analyse the data you submit to us. The data provides views of the big picture as well as of your own delivery and performance in context.

Ngā Kete brings together information so you can use it to support the production of your Investment Plan. In your Investment Plan you need to show us you understand your data and are responding to any areas that need improvement.

<i>Transitions into tertiary education</i>	The 'Secondary to Tertiary Transition' app shows the learner's first enrolment in qualification-based tertiary education for school leavers.	From this information you are able to profile where your learners are currently coming from and possible opportunities to attract learners from other schools. <i>Provision</i>	The 'My Provision' apps use enrolment data from the Single Data Return (SDR) and the Industry Training Register (ITR) to provide a picture of the 'who, where, and what' in enrolment for tertiary education. This app provides learner data broken down by a number of elements including gender, ethnicity, and age. <i>Regional Information</i>	This app shows tertiary enrolments by region including information on learner demographics and programmes enrolled in. It also shows learner migration in terms of where they left school and where they enrolled in tertiary education.	Your Plan should show how you respond to demands and needs in your region. <i>Performance</i>	The <i>'My Performance'</i> apps provide a detailed view of data your organisation reports that contribute to your educational performance indicators (EPIs) through the SDR or the ITR. The <i>'Tertiary Provision'</i> apps allow you to compare your organisations' performance against other TEOs.	<p>In your Investment Plan we want to see that you understand, in detail, how your learners are achieving. These apps will help you identify areas of success as well as areas for improvement. You will need to be able to identify any groups that are doing less well in specific areas and put in place plans to address this.</p> <p>As well as showing improvement against your own results, we want to see that your organisation is achieving well compared to other tertiary providers.
