Purpose

1. This report provides printed copies of the Tertiary Education Commission's (TEC's) Statement of Performance Expectations 2020/21 (SPE) for presenting to the House of Representatives.

Publishing our SPE

2. Our SPE will be published on the TEC website by 30 June 2020.
3. This meets our requirements under the Crown Entities Act 2004 (CEA) to publish our final SPE on our website as soon as practicable after providing the final SPE to the responsible Minister [s149L CEA].
4. The Crown Entities Act 2004 requires you to present TEC's SPE to the House of Representatives before or on the date the TEC Annual Report for the year ended 30 June 2020 is presented [s249L CEA]. Our Annual Report is likely to be published and provided to you to table in the House of Representative in November 2020.
5. Five printed copies of our SPE are enclosed. Two copies are for you to present to the House of Representatives.
6. We will liaise with your office to determine when to provide the Bills Office with the required 30 copies of our SPE and a PDF file.

We may amend our SPE later in the year

7. We will consider making amendments to our SPE in the latter half of the 20/21 financial year once we understand the full impact of COVID-19 and will apply section 149K of the Crown Entities Act 2004 to do so.
8. Section 149 K of the act states that a Crown entity may amend its final SPE at any time, and must amend its SPE if the intentions and undertakings in the final SPE are significantly altered or affected by a change in the entity's operating environment.
